

## **BY-LAW No. 3 - ROADS**

Did you know that Council's By-Law No. 3 – Roads exists to manage, control and regulate certain uses of roads in the Council area. This assists in preventing damage to buildings and structures on roads and preventing certain nuisances on roads.

The following are some examples of activities that require permission from the Council before occurring on roads in the Council area:

- Use an amplifier or other device for the purpose of amplifying sound
- Cause or allow and animal to stray onto, move over, or graze on a road
- Erect, install, place or maintain any structure, object or material that causes an obstruction
- Sing, busk or play a musical instrument

Council's Draft Annual Business Plan 2022-2023, Long Term Financial Plan 2022-2042 (including 2022-2023 Budget), Fees and Charges 2022-2023 and Rating Policy 2022-2023 are available for public comment and may be viewed at the Quorn Council Office, Hawker Motors or on Council's website www.frc.sa.gov.au

Council is required under Section 123(4)(a) of the Local Government Act, 1999 to consult with the public on its Annual Business Plan. Council is required under Section 151 and Section 156 of the Local Government Act, 1999 to consult with the public on any changes to rating methodologies. These consultations are being undertaken concurrently.

Ratepayers are encouraged to make a written submission regarding the draft Annual Business Plan 2022-2023, Long Term Financial Plan 2022-2042 (including 2022-2023 Budget), Fees and Charges 2022-2023 and Rating Policy 2022-2023, including any proposed changes to its rating methodology, addressed to the Chief Executive Officer at PO Box 43, Quorn SA 5433 to be received by 5.00 pm Tuesday 14 June 2022.

Council will set aside one hour at the commencement of its Ordinary Meeting to be held on Tuesday 21 June 2022 for any ratepayers who wish to address Council on the Draft Annual Business Plan 2022-2023, Long Term Financial Plan 2022-2042 (including 2022-2023 Budget), Fees and Charges 2022-2023 and Rating Policy 2022-2023.

Those ratepayers who would like to address Council on any of the above draft documents are required to make an appointment by telephoning Council on 8620 0500.

## **COMMUNITY CONSULTATION—CRADOCK**

An application has been received from the Wallis Hospitality Group Pty Ltd for the use of the land as highlighted below, situated in Cradock, for the use by the Cradock Hotel.

The proposal includes formalising the caravan and camping sites and the planting of trees to beautify the area to the rear of the hotel and to formalise use of the area at the front of the hotel. These areas are currently identified as road reserve.

Council will work with the applicant to improve vehicle and pedestrian access of the site to improve safety and amenity for patrons accessing the area.



The application is for a five (5) year period and does not involve the erection of any permanent structures.
