

#### **ELECTORAL ROLL**

Please check that your current address is up to date with the Electoral Commission. If you have recently moved to The Flinders Ranges Council area or moved addresses within the area, please make sure your electoral roll address is up to date to ensure that your voice can be heard

#### **SUPPLEMENTARY (COUNCIL) VOTERS ROLL**

Forms to apply for Councils Supplementary Roll are available at the Council Office or on the Council website under the Council Forms tab.

Please make sure that you have your application in asap to be eligible to vote in the pending National Radioactive Waste Management Facility Ballot.

# DOG and CAT REGISTRATION DUE 31 AUGUST 2019.

All registrations are to be completed online through the DACO system. Renewal letters/SMS/Emails should have been received.

If you require help please come into the Quorn Council Office for assistance.

It is an owners responsibility to register their dog and cat, therefore if you have not received your renewal letter please contact Council or log onto the DACO system. Remember all dogs and cats are required by law to be Microchipped and all dogs and cats born after 1 July 2018 need to be desexed.

#### **EXEMPTIONS TO THE ABOVE MAY APPLY IF:**

- Dogs are defined as Working Livestock Dogs; (must be microchipped)
- · A Vet has granted an exemption;
- Dog or cat born prior to 1 July 2018;
- Dogs belonging to Dog SA members;
- Cats belonging to FASA or Cat Fancy of SA members;
- · Greyhounds registered to Greyhound Racing SA;
- Dog and Cat Management Board Exemptions.

#### **DROUGHT ASSISTANCE PRIMARY PRODUCTION**

#### **Rates Financial Support**

As part of its Annual Business Plan and Budget for the 2019-2020 financial year Council has established a budget line to reduce the financial burden of general rates on drought affected primary production ratepayers. Council will provide, upon application and subsequent assessment and approval, a credit against the property general rates liability.

## **MAYOR'S MESSAGE**

Hello again to all our residents.

We've got a bit to report this month, and I'll start with Council's Drought support initiatives. Council has instigated a rate relief program for Primary Producers on Primary Production land — a simple application process will be required and will see rates for the current year remitted to the same level as previous. Whilst we acknowledge this isn't a big factor, it is a reflection of our concern about the difficult conditions in our rural and pastoral sectors. We have also appointed a Droughts and Grants Support Officer to engage with the properties and families thus identified, to assist them with understanding and connecting with the existing support programs from various providers to sustain the rural are as through the drought. I certainly encourage ALL of our primary producers to apply for support through both programs FRC have.

The NRWMF issue has come back into the spotlight with the dismissal of the Barngarla case against Kimba Council, and a subsequent request from Minister Canavan to resume the long stalled ballot process to determine the level of community support for the proposal. Council has agreed to resume the ballot process, but will not initiate voting until the independent risk assessment/analysis, which we have been seeking Federal funding to undertake over recent months, is completed and available to the community. There has been significant media interest in this resumption of process, and FRC's actions delaying the ballot in our area and thus breaking the concurrent aspects of the Kimba and Wallerberdina processes.

It is important to note that some preparatory processes for commencing the ballot will be taking place in the interim, including opening of the Supplementary Roll for the AEC to work with – If you are not already on the Electoral Roll in this Council Area you can amend your details with the AEC, and non-resident ratepayers can make application to Council for inclusion from now. Further details about closing dates for the Roll, and ballot dates, will be provided in due course. This is a crucial issue for our community, and Council actively encourages all eligible residents and ratepayers to ensure they are able to have their say in the ballot.

Over the past few months, efforts to establish a community-based committee to assist in attracting a GP to Quorn, to take over from Dr Tony as he prepares for retirement, have occurred without sufficient support and engagement from the community. A further meeting is to be held in the Council Chambers on Monday 9 September 2019 at 7:30 and I encourage all community members to read the attached flyer and get involved.

Our recruitment process for the CEO position is now underway, and we are looking forward to a strong field of applicants for this critical role in guiding and managing Council through the coming years.

# We need YOU to become involved in the Community

Our community has been extremely well served for over 28 years by Dr Tony Lian-Lloyd, however he is looking towards retirement.

# The community must now take the opportunity to commence planning for and attracting a replacement GP.

A Resident GP is **VERY IMPORTANT** to our Community

The security and viability of the Hospital

### OUR LARGEST EMPLOYER

is linked to having a resident GP available to service patients there.

- It will be difficult to retain, and near impossible to attract, young families and older people without the security of a local Doctor and a functional Hospital to provide healthcare.
- WITHOUT a resident GP community members would need to travel for medical needs.
- WITHOUT a resident GP local business such as the pharmacies would see less business as well as the Hospital with risk of job losses.
- Less business activity, due to less employment and less services in the region, will have a serious effect on our town and regional economic stability.



# How can you help?

Securing a replacement GP is going to be a challenge for the whole community. We need to become proactive and develop a strong "sales pitch" to compete with many other towns in this position, who are offering housing, vehicles, business support and attractive payment packages. UNFORTUNATELY it is a competition to secure a GP in a regional town!

Our town needs to offer good educational prospects for their children, good employment prospects for their partner, a high standard of housing and an active, engaged, welcoming and progressive community in which to live with their family.

There have been several meetings held to establish a working group to assist in developing a strategy, unfortunately not enough community members have attended. For us to be successful we need **EVERYONE** to become involved.

We need YOU to talk to your family and friends about this issue. We need you to think about how **YOU** can contribute to the process of attracting a new Doctor.

This is not an issue for complacency, nor can we leave it to someone else. Failure to act will effect the viability and vibrancy of our Community.
